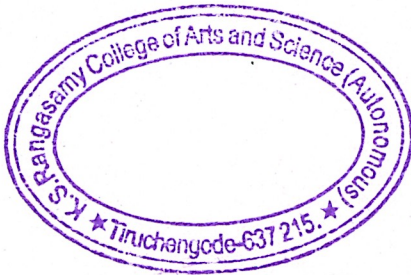

The Chairperson stated that the departmental budget includes provisions for conducting various academic activities such as workshops, seminars, guest lectures, intercollegiate meets, and interdepartmental meets.

The budget also includes the construction of a media studio for the Visual Communication Department, the renovation of the Biochemistry laboratory, the purchase of computers, and the upgradation of the Local Area Network (LAN) infrastructure. The laboratory budget provides for the procurement of computers, laboratory equipment, chemicals, and other essential materials. The library budget includes the purchase of new textbooks, journals, and magazines in accordance with the revised curriculum to be implemented from the academic year 2026-2027 onwards.

The Chairperson of the Finance Committee endorsed the above views and the resolutions have been passed.

It was seconded by Dr. M. Venkatesh and **approved**.

The Principal & Chairperson of the Finance Committee submitted the detailed audited annual statements.

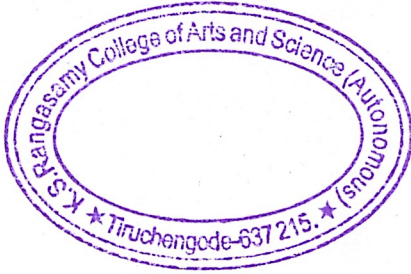
The resolutions were seconded by Mr. N. Ravichandran and they were approved.
